Kovalska is committed to a responsible approach in everything it does for society and its employees.


A word from the CEO

Behind our backs is a history of 68 years of successful development. A family of founders leads our team. We manage the business according to our values to benefit our country and our community.





Kovalska Group production assets are located in the center, north, and west of Ukraine. Assets in the Kyiv and Chernihiv regions did not suffer substantial damage during the full-scale russian invasion and as of 2024, they operate at their full production capacity.

An asset in the south of Ukraine (Nova Kakhovka), the autoclaved aerated concrete plant, halted its operations due to russian occupation.

The western part of Ukraine is far from invasion attempts and is experiencing a rise in demand for supplies due to the internally relocated population from the eastern and southern parts of the country.

Here in Rozvadiv, Lviv region, Kovalska is developing the production of environmentally friendly aerated concrete blocks and panels. The Group is actively involved in projects relevant to the ongoing reconstruction efforts in Ukraine.

The Division unites eight powerful enterprises with a unique production process automation system, innovative equipment, and a strong raw material base. The division sites are certified according to the ISO 9001:2008 quality management system.

The division is represented on the market by two popular brands: "Concrete from Kovalska" concrete mixtures and prefabricates of different classes of strength. And "AVENUE" paving tiles and blocks. We use chemical and mineral admixtures from leading European companies, which allows us to produce premium-class products.

The Division produces a wide range of dry and wet mortar mixtures under the brand SILTEK. It was the first producer of dry mixtures in Ukraine that employed silo delivery and created specialised mixtures for mechanical applications.

The production facility integrates a certified laboratory with technologically advanced machinery from the best manufacturers in the world, including those from Finland, Germany, Norway, Spain, and France.

It also integrates a certified laboratory with modern and advanced equipment. Regulatory testing allows for quality control at all stages of production, the development of new mix formulations, and the improvement of existing ones.

Division Materials specialises in the production of granite products, including crushed stone, stone screening, and fine aggregates. The enterprises are equipped with the most modern equipment from such manufacturers as Metso Minerals, Caterpillar, Epiroc, Komatsu, and Hitachi and work in a sustainable and innovative way.

A mining facility in the Lviv region provides sand and limestone materials. It includes sand and limestone quarries, mine furnaces for burning limestone, and a factory that produces silicate bricks.

Raw materials are delivered to the Group's production facilities by its own rail and river fleet.

The success of our vertically integrated business in Central Ukraine has already started to spread to other regions of Ukraine since 2019. We have invested in aerated concrete production in the South and sand and limestone quarries in the West of Ukraine. We are evaluating further initiatives that will truly make us a nationwide Group.

Within the framework of our priorities, several projects and programs have been launched and are working, and more are planned for implementation.








Sustainability

As part of the development of industry and innovation, "Kovalska" has been investing in its R&D center for ten years. It develops high-quality building materials, including recycled products. In some areas of the production cycle, zero-waste production is applied to reduce the number of outputs to almost zero.

To implement the principle of responsible consumption and production, the "Kovalska" innovation and technology center is constantly researching ways to reuse materials to create new, more ecological recipes for building materials. Where it is economically feasible and meets the highest quality requirements, the company resorts to increasing the share of recycled materials in new products.







Sustainability

For the development of quality education, which affects the sustainable development of cities and communities, we launched educational projects with architects to raise awareness of this topic among specialists and the general public. Such projects became the regular "Kovalska meetup," an educational and discussion platform with the involvement of world architects.

The development project "Kudriavka" became a vivid example of a responsible approach towards the sustainable development of cities and communities. The company applied the principles of transparency and responsibility to renovating historical heritage. As part of the development of the territory, in-depth studies of traffic flows and expectations of the local community from the new construction project were conducted. The terms of reference for the architectural studio that will be involved in the development of "Kudriavka" include an analysis of the local community needs and a request for the preservation and revitalization of the historical part of the complex.





The projects of our ambition

Rozvadiv-HUB

Kovalska is Ukraine's largest integrated construction materials producer, working on a wide set of investment projects united in the so called "Rozvadiv HUB" located on a 346-acre land plot in Rozvadiv village (30 miles south of Lviv, Western Ukraine), which the company purposefully acquired in 2020.

- 1. Limestone quarry (already operational)
- 2. Sand quarry (already operational)
- 3. Autoclaved aerated concrete plant
- 4. Dry construction mixes plant
- A number of site infrastructure projects (roads, electricity substations, shops, natural gas supply, etc.)





UNIT.City B04 and B06

Campuses B04 and B06 are planned with the use of BIM technology. They meet all requirements for class A energy efficiency and are certified according to the LEED Silver green building standard. The Reynaers Aluminum element facade system, Guardian Glass double-glazed windows, and VRV multi-zone air conditioning are used in the project. The refined beauty of the campuses was created in partnership with APA Wojciechowski.

The total area of the two campuses is 40,000 m2. Each floor of the two business centers is designed with a column pitch of 8.1 m. This solution makes the space as open as possible. On each floor, residents get a substantial amount of flexible open space. It can be rescheduled without restrictions.

Campus lighting is designed in such a way that the system can be managed from a mobile application.







The Group's shareholders determine the strategic directions of the Group's development and approve the Group's Strategy. They also approve the new business, sources, and terms of external financing.

The Corporate Center acts as the methodological and control center of the Group, that:

- 1) Is responsible for the implementation of the Group Strategy and strategic initiatives
- 2) Forms and approves standards for all directions of the Group activities
- 3) Determines performance indicators and reporting formats for divisions and segments
- 4) Monitors the activities of divisions and segments

The Division is a structural business unit of the Kovalska Group, which is the center of profit generation and combines production assets with similar products and activities.

The Division's operating company is a separate legal entity that manages the Division's activities and owns the Division's facilities.

- The responsibility of the Operating Company of the Division:
- Management of sales and customer accounts (receivables)
- Implementation of integrated business planning of the Division's activities (balancing demand, production, and logistics capabilities and limitations)
- Management of production and warehouses
- Division logistics management
- Management of other purchases and related accounts payable
- Management of capital expenditures aimed at supporting production assets. The Corporate Center approves capital costs for development
- Management of operational expenses of the Division

The Business Development segment combines the Group's activities in the search for new assets and business opportunities, engineering and construction of industrial facilities, as well as integration of new assets (M&A)

The service segment combines enterprises that provide universal services to all enterprises of the Group. In 2022, it included the following services: IT, Accounting, Payment Factory, Marketing Services, and R&D.
